**RESEARCH**

---

To engage with material from antiquity is to have the chance to exercise empathy that goes beyond the boundaries of time and culture, because it is an act of empathy to care about what we have been left by strangers who have long-since died. As a scholar of the Hebrew Bible, I am fascinated by issues that are profoundly embedded within the human condition, such as death, identity, illness, justice, humour and the value of humanity / the humanities. I care about material within the Hebrew Bible as well as broader evidence from antiquity (manuscripts, inscriptions, artefacts, papyri, and ostraca etc), and I specialise in material dated to the Neo-Babylonian and Persian periods, because this is a formative period for much of the material within the Hebrew Bible. A key feature of my research is dialogue across disciplinary divides, which facilitates the emergence of deeper understandings of evidence, more sophisticated methodological frameworks, and more precise analytical language. Given the popularity and enduring relevance of the Biblical material it is urgently important to do this work.
